ONLY available to families who need one hour of kindergarten child care because they have an older sibling in grades 1-8 at HCS. Registration fee/form still required.

OTHER FEES

- A \$20 change fee will be charged for any schedule change.
- A late fee of \$10 for **each** child will be charged for every 10 minutes past 6:00 p.m.
- Children must come only on the number of days a week for which they are registered. A \$10 an hour fee will be charged for each child on any extra day.
- Kindergarten hour applies to regular school days only. Kindergarten child must be picked up by 3:00 p.m. or a \$15 per hour emergency charge applies. This service is not available on non-school days or minimum days.

SCHEDULE CHANGES

- Notice of change must be submitted via EMAIL to Margaret Murray mmurray@hconline.org by the 10th of the month to go into effect the following month. No changes will be made unless an EMAIL has been sent to Mrs. Murray.
- There will be a \$20 change fee added to your account for all changes.

ANY FAMILY WITH FEES OR CHARGES OUTSTANDING ON THEIR ACCOUNT WILL NOT BE ALLOWED TO SIGN IN TO KIDS' OVERTIME.
